**ORDER APPROVING EMPLOYMENT OF INCE (GIBRALTAR) LIMITED TOGETHER
WITH INCE CONSULTANCY (GIBRALTAR) LIMITED AS GIBRALTAR COUNSEL TO
ASSIGNEE, MARC C. HEALY, AND AUTHORIZING ASSIGNEE TO EXECUTE
ENGAGEMENT LETTER**

THIS MATTER, having come before the Court for hearing on August 3, 2022 at 9:00 a.m. (the "Hearing") upon the Motion to Employ Ince (Gibraltar) Limited Together with Ince Consultancy (Gibraltar) Limited as Gibraltar Counsel to Assignee, Mark C. Healy, and to Authorize Assignee to Execute Engagement Letter (the "Motion") filed by Mark C. Healy (the "Assignee"), solely as the Assignee for the benefit of creditors of Crystal Cruises LLC ("Crystal Cruises"), Crystal Holdings U.S. LLC ("Crystal Holdings"), and Crystal AirCruises LLC ("Crystal AirCruises", and, together with Crystal Cruises and Crystal Holdings, collectively, the "Assignors") and not individually. Upon the representations that (Gibraltar) Limited (together with its affiliate Ince Consultancy (Gibraltar) Limited referred to as "Ince") holds no interest adverse to the Assignors or the estates in the matters upon which Ince is to be engaged, that Ince is disinterested, and that Ince's employment is necessary and is in the best interests of the estates; pursuant to Florida Statutes § 727.108(7); and the Court, having reviewed the Motion, having heard argument of counsel for the Assignee, finding that notice of the Motion and the Hearing was sufficient, there being no objection from any creditor or other interested party to the relief requested

in the Motion, and good cause appearing, it is hereby

ORDERED AND ADJUDGED:

1. The Motion is hereby GRANTED.
2. The employment of Ince as Gibraltar Counsel to the Assignee is APPROVED.
3. The Assignee is authorized to execute the engagement letter with Ince, attached as Exhibit “A” to the Motion, and pay any related retainer.
4. The Assignee shall give the Assignors and all creditors notice of the proposed payment of any fees and expenses to Ince as required by Florida Statutes § 727.111(4), and no such payment shall be made absent further order of the Court.
