**ORDER GRANTING MOTION FOR APPROVAL AND PAYMENT OF FEES INCURRED  
BY KENNEDYS CHUDLEIGH LTD. AS BERMUDA COUNSEL TO THE ASSIGNEE FOR  
THE PERIOD MARCH 9, 2022 THROUGH JULY 31, 2022**

**THIS CAUSE** came before the Court for hearing on Thursday, September 22, 2022 at 11:00 a.m. upon the *Motion for Approval and Payment of Fees Incurred by Kennedys Chudleigh Ltd. as Bermuda Counsel to the Assignee for the Period March 9, 2022 through July 31, 2022* (the "Motion"), filed on negative notice by Mark C. Healy (the "Assignee"), solely in his capacity as the Assignee for the benefit of creditors of Crystal Cruises LLC, Crystal Holdings U.S. LLC, and Crystal AirCruises LLC (collectively, the "Assignors"), pursuant to which Kennedys Chudleigh Ltd. seeks compensation in the amount of \$16,828.50 for the period of March 9, 2022 through July 31, 2022. The Court, having considered the Motion and the record in this proceeding, including the *Notice of Objection* and *Amended Notice of Objection* filed by Denholm Port Services Ltd. (collectively, the "Denholm Objection"), having heard argument of counsel, finding that notice of the Motion and the hearing was sufficient, and good cause appearing, it is hereby

**ORDERED** that:

1. The Motion is **GRANTED**.

2. The Denholm Objection is OVERRULED.
3. Kennedys Chudleigh Ltd., as Bermuda counsel to the Assignee, is awarded fees in the amount of \$16,828.50, which represents 100% of the fees requested in the Motion.
4. The Assignee is authorized to pay to Kennedys Chudleigh Ltd. the sum of \$16,828.50.
5. In making the foregoing award, the Court finds that the amounts awarded represent reasonable compensation for actual and necessary services rendered and expenses incurred by Kennedys Chudleigh Ltd. for the benefit of the assignment estate.
