ORDER SUSTAINING, IN PART, ASSIGNEE'S TWENTY-FOURTH OMNIBUS
OBJECTION TO CONSUMER CLAIMS [ECF 349]

THIS MATTER came before the Court upon the Assignee's Twenty-Fourth Omnibus Objection to Claims [ECF 349] (the "Objection") filed on June 23, 2023, by Mark C. Healy (the "Assignee"), solely in his capacity as the Assignee for the benefit of creditors of Crystal Cruises, LLC, Crystal Holdings U.S., LLC, and Crystal AirCruises, LLC (collectively, the "Assignors"). The Court, having reviewed the Objection and the record in this case, finding that notice of the Objection was sufficient and properly served on interested parties pursuant to the Court's Order Granting Assignee's Motion for Entry of an Order Approving Procedures for Objections to Consumer and Employee Claims [ECF 257] (the "Claims Procedure Order"), noting that no response to the Objection from any claimant listed on the attached Exhibit 1 was filed within the 21-day period set forth in the Objection and the Claims Procedure Order nor was any response received by the Assignee that has not been resolved, finding that the relief requested in the Objection is in the best interests of the Assignors' estates, and otherwise finding that good and sufficient cause exists for granting the relief set forth herein, does hereby ORDER AND ADJUDGE that:

1. The Objection is **SUSTAINED** as to each of the proofs of claim identified on **Exhibit 1** attached to this Order.
