**ORDER SUSTAINING ASSIGNEE'S THIRTY-THIRD OMNIBUS OBJECTION TO  
CONSUMER CLAIMS [ECF 373]**

**THIS MATTER** came before the Court upon the *Assignee's Thirty-Third Omnibus Objection to Claims* [ECF 373] (the "Objection") filed on July 17, 2023, by Mark C. Healy (the "Assignee"), solely in his capacity as the Assignee for the benefit of creditors of Crystal Cruises, LLC, Crystal Holdings U.S., LLC, and Crystal AirCruises, LLC (collectively, the "Assignors"). The Court, having reviewed the Objection and the record in this case, finding that notice of the Objection was sufficient and properly served on interested parties pursuant to the Court's *Order Granting Assignee's Motion for Entry of an Order Approving Procedures for Objections to Consumer and Employee Claims* [ECF 257] (the "Claims Procedure Order"), noting that no response to the Objection from any claimant listed on the attached **Exhibit 1** was filed within the 21-day period set forth in the Objection and the Claims Procedure Order nor was any response received by the Assignee that has not been resolved, finding that the relief requested in the Objection is in the best interests of the Assignors' estates, and otherwise finding that good and sufficient cause exists for granting the relief set forth herein, does hereby **ORDER AND ADJUDGE** that:

1. The Objection is **SUSTAINED** as to each of the proofs of claim identified on **Exhibit 1** attached to this Order.

2. Each of the proofs of claim identified on **Exhibit 1** attached to this Order is treated as set forth in **Exhibit 1**.
3. This Order has no res judicata, estoppel, or other effect on the validity, allowance, or disallowance of any proof of claim identified in the Objection that is not listed on **Exhibit 1** attached to this Order.
4. The Assignee is authorized to take all actions necessary or appropriate to give effect to this Order.
5. The terms, conditions, and provisions of this Order shall be immediately effective and enforceable upon entry hereof.
6. The Court shall retain jurisdiction to resolve any dispute arising from or relating to this Order.
