**ORDER SUSTAINING ASSIGNEE'S OBJECTION TO CLAIM OF DESTINATION  
WORLD TRAVEL**

**THIS MATTER** came before the Court upon the Assignee's Objection to Claim of Destination World Travel [ECF 532] (the "Objection") filed on December 20, 2023 by Mark C. Healy (the "Assignee"), solely as the Assignee for the benefit of creditors of Crystal Holdings U.S., LLC, Crystal Cruises LLC, and Crystal Aircruises, LLC (the "Assignors"), objecting to Claim No. 1589 (the "Claim") filed by Destination World Travel (the "Claimant"), and the Court, having reviewed the Objection and record in this case, finding that notice of the Objection was sufficient and properly served on the Claimant and interested parties pursuant to §§ 727.103, 727.111(4) and 727.113, noting that no response to the Objection from the Claimant was received by the Assignee or filed within the 21-day negative notice period set forth in the Objection, finding that the relief requested in the Objection is in the best interest of the Assignor's estate, and otherwise finding that good and sufficient cause exists for granting the relief set forth herein, does hereby

**ORDER AND ADJUDGE that:**

1. The Assignee's Objection to the Claim is hereby SUSTAINED.
2. Destination World Travel's Claim attached as Exhibit "A" to the Objection and otherwise set

forth in the Objection is disallowed and expunged in its entirety.

3. The Assignee is authorized to take all actions necessary and appropriate to give effect to this Order.
4. The terms, conditions, and provisions of this Order shall be immediately effective and enforceable upon entry hereof.
5. This Court retains jurisdiction to interpret, implement, and enforce the provisions of this Order.
