**AGREED ORDER GRANTING IN PART AND DENYING IN PART ASSIGNEE'S
OBJECTION TO CLAIM OF KARYN FARR CLAIM NO. 2688**

THIS MATTER came before the Court upon the Assignee's *Third Omnibus Objection to Disputed Vendor Claims* [ECF 476] (the "Objection") filed on October 18, 2023 by Mark C. Healy (the "Assignee"), solely as the Assignee for the benefit of creditors of Crystal Holdings U.S., LLC, Crystal Cruises LLC, and Crystal Aircruises, LLC (the "Assignors"), objecting to Claim No. 2688 (the "Claim") filed by Karyn Farr ("Farr" and together with the Assignee, the "Parties"), and the Court, having reviewed the Objection, the Claim and the record in this case, finding that notice of the Objection was sufficient, being advised of the agreement between the Parties as to the treatment of the Claim and the form of this Order, and being otherwise fully advised in the premises, does hereby

ORDER AND ADJUDGE that:

1. The Assignee's Objection to the Claim is hereby GRANTED in part and DENIED in part as set forth below.
2. \$50,527.27 of the Claim is allowed.
3. The Claim's remaining balance of \$12,816.93 is denied.

4. Farr shall have no claim upon the assets of the Assignor's Estate except as is expressly set forth in this Order.
5. The Assignee is authorized to take all actions necessary and appropriate to give effect to this Order.
6. The terms, conditions, and provisions of this Order shall be immediately effective and enforceable upon entry hereof.
7. This Court retains jurisdiction to interpret, implement, and enforce the provisions of this Order.
