**AGREED ORDER SUSTAINING ASSIGNEE'S OBJECTION TO CLAIM OF KADESH  
TRAVEL AGENCY'S CLAIM NO. 2595**

**THIS MATTER** came before the Court upon the Assignee's Objection to the Claim of Kadesh Travel Agency as made part of the Assignee's *Third Omnibus Objection to Disputed Vendor Claims* [ECF 476] (the "Objection") filed on October 18, 2023 (the "Objection") by Mark C. Healy (the "Assignee"), solely as the Assignee for the benefit of creditors of Crystal Holdings U.S., LLC, Crystal Cruises LLC, and Crystal Aircruises, LLC (the "Assignors"), objecting to Claim No. 2595 (the "Claim") filed by Kadesh Travel Agency ("Kadesh" and together with the Assignee, the "Parties"), and the Court, having reviewed the Objection, the Claim and the record in this case, finding that notice of the Objection was sufficient, being advised of the agreement between the Parties as to the treatment of the Claim and the form of this Order, and being otherwise fully advised in the premises, does hereby

**ORDER AND ADJUDGE that:**

1. The Assignee's Objection to the Claim hereby SUSTAINED in part and DENIED in part as set forth below.
2. \$455.76 of the Claim is allowed.

3. The balance of the Claim, or \$43,950.72, is denied.
4. Kadesh shall have no claim upon the assets of the Assignor's Estate except as is expressly set forth in this Order and the Assignee's allowance of Claim 2595.
5. The Assignee is authorized to take all actions necessary and appropriate to give effect to this Order.
6. The terms, conditions, and provisions of this Order shall be immediately effective and enforceable upon entry hereof.
7. This Court retains jurisdiction to interpret, implement, and enforce the provisions of this Order.
