**AGREED ORDER SUSTAINING IN PART AND DENYING IN PART ASSIGNEE'S
OBJECTION TO APEX SHIPPING AGENCY LIMITED'S CLAIM NO. 2190**

THIS MATTER came before the Court upon the Assignee's Objection to the Claim of Apex Shipping Agency Limited as made part of the Assignee's *Amended First Omnibus Objection to Disputed Vendor Claims* [ECF 473] (the "Objection") filed on October 6, 2023 (the "Objection") by Mark C. Healy (the "Assignee"), solely as the Assignee for the benefit of creditors of Crystal Holdings U.S., LLC, Crystal Cruises LLC, and Crystal Aircruises, LLC (the "Assignors"), objecting to Claim No. 2190 (the "Claim") filed by Apex Shipping Agency Limited ("Apex" and together with the Assignee, the "Parties"), and the Court, having reviewed the Objection, the Claim and the record in this case, finding that notice of the Objection was sufficient, being advised of the agreement between the Parties as to the treatment of the Claim and the form of this Order, and being otherwise fully advised in the premises, does hereby

ORDER AND ADJUDGE that:

1. The Assignee's Objection to the Claim is hereby SUSTAINED in part and DENIED in part as set forth below.
2. \$10,000 of the Claim is allowed and is deemed a general unsecured claim to be

paid pro rata with other general unsecured claims based on the ratio of assets available for distribution to total unsecured claims.

3. The balance of the Claim, or \$9,012.80, is denied.
4. Apex shall have no claim upon the assets of the Assignor's Estate except as is expressly set forth in this Order and the Assignee's allowance of Claim 2190.
5. The Assignee is authorized to take all actions necessary and appropriate to give effect to this Order.
6. The terms, conditions, and provisions of this Order shall be immediately effective and enforceable upon entry hereof.
7. This Court retains jurisdiction to interpret, implement, and enforce the provisions of this Order.
