**AMENDED AGREED ORDER SUSTAINING IN PART AND DENYING IN PART
ASSIGNEE'S OBJECTION TO CLAIM OF DENISE ALEVY AND GARY ALEVY**

THIS MATTER came before the Court upon the Assignee's *Objection to Claim of Denise Alevy and Gary Alevy* [ECF 550] (the "Objection") filed on January 8, 2024 (the "Objection") by Mark C. Healy (the "Assignee"), solely as the Assignee for the benefit of creditors of Crystal Holdings U.S., LLC, Crystal Cruises LLC, and Crystal Aircruises, LLC (the "Assignors"), objecting to Claim No. 2654 (the "Claim") filed by Denise and Gary Alevy (collectively "Alevy" and together with the Assignee, the "Parties"), and the Court, having reviewed the Objection, the Claim and the record in this case, finding that notice of the Objection was sufficient, being advised of the agreement between the Parties as to the treatment of the Claim and the form of this Order, and being otherwise fully advised in the premises, does hereby

ORDER AND ADJUDGE that:

1. The Assignee's Objection to the Claim hereby **SUSTAINED** in part and **DENIED** in part as set forth below.
2. \$300,000.00 of the Claim is allowed and shall be deemed and treated as a general unsecured claim against the Assignor's Estate.

3. The balance of the Claim, or \$700,000, is denied.
4. Alevy shall have no claim upon the assets of the Assignor's Estate except as is expressly set forth in this Order and the Assignee's allowance of Claim 2654.
5. The Assignee is authorized to take all actions necessary and appropriate to give effect to this Order.
6. The terms, conditions, and provisions of this Order shall be immediately effective and enforceable upon entry hereof.
7. This Court retains jurisdiction to interpret, implement, and enforce the provisions of this Order.
