**ORDER GRANTING MOTION FOR APPROVAL AND PAYMENT OF FEES AND  
REIMBURSEMENT OF EXPENSES INCURRED BY APPLEBY (ISLE OF MAN) LLC AS  
ISLE OF MAN COUNSEL TO THE ASSIGNEE FOR THE PERIOD OF MARCH 8, 2024  
THROUGH MARCH 31, 2024**

**THIS CAUSE** came before the Court for hearing on May 23, 2024, at 11:15 a.m. (the “Hearing”), upon the *Motion for Approval and Payment of Fees and Reimbursement of Expenses Incurred by Appleby (Isle of Man) LLC as Isle of Man Counsel to the Assignee for the Period of March 8, 2024 Through March 31, 2024* [DE 715] (the “Motion”), filed on negative notice by Mark C. Healy (the “Assignee”), solely in his capacity as the Assignee for the benefit of creditors of Crystal Cruises LLC, Crystal Holdings U.S. LLC, and Crystal AirCruises LLC (collectively, the “Assignors”), pursuant to which Appleby (Isle of Man) LLC seeks compensation in the amount of £3,014.00 and reimbursement of expenses in the amount of £90.42, for a total award of £3,104.42, for the period of March 8, 2024 through March 31, 2024. The Court, having considered the Motion and the record in this proceeding, noting that no objections to the Motion have been filed, finding that notice of the Motion and the Hearing was sufficient, and good cause appearing, it is hereby

**ORDERED** that:

1. The Motion is hereby **GRANTED**.

2. Appleby (Isle of Man) LLC, as Isle of Man counsel to the Assignee, is awarded fees in the amount of £3,014.00 and expenses in the amount of £90.42, for a total award of £3,104.42, which represents 100% of the fees and expenses requested in the Motion.
3. The Assignee is authorized to pay to Appleby (Isle of Man) LLC the sum of £3,104.42.
4. In making the foregoing award, the Court finds that the amounts awarded represent reasonable compensation for actual and necessary services rendered and expenses incurred by Appleby (Isle of Man) LLC for the benefit of the assignment estates.
