**AGREED ORDER SUSTAINING IN PART AND DENYING IN PART ASSIGNEE'S
OBJECTION TO OAK VIEW GROUP LLC'S AMENDED CLAIM NO. 2719**

THIS MATTER came before the Court upon the Assignee's Objection to the Amended Claim of Oak View Group LLC [ECF 580] (the "Objection") filed on February 1, 2024 (the "Objection") by Mark C. Healy (the "Assignee"), solely as the Assignee for the benefit of creditors of Crystal Holdings U.S., LLC, Crystal Cruises LLC, and Crystal Aircruises, LLC (the "Assignors"), objecting to the Amended Claim No. 2719 (the "Claim") filed by Oak View Group LLC ("Oak View" and together with the Assignee, the "Parties"), and the Court, having reviewed the Objection, the Claim and the record in this case, finding that notice of the Objection was sufficient, being advised of the agreement between the Parties as to the treatment of the Claim and the form of this Order, and being otherwise fully advised in the premises, does hereby

ORDER AND ADJUDGE that:

1. The Assignee's Objection to the Claim is hereby **SUSTAINED** in part and **DENIED** in part as set forth below.
2. Oak View is hereby determined to be an unsecured creditor of the Assignor's Estate.
3. \$305,320.00 of the Claim is allowed and is deemed a general unsecured claim to be

paid pro rata with other general unsecured claims based on the ratio of assets available for distribution to total unsecured claims.

4. Oak View shall have no claim upon the assets of the Assignor's Estate except as is expressly set forth in this Order.
5. The Assignee is authorized to take all actions necessary and appropriate to give effect to this Order.
6. The terms, conditions, and provisions of this Order shall be immediately effective and enforceable upon entry hereof.
7. This Court retains jurisdiction to interpret, implement, and enforce the provisions of this Order.
