**ORDER GRANTING ASSIGNEE'S MOTION TO APPROVE PAYMENT TO CRYSTAL

THIS CAUSE came before the Court upon the *Assignee's Motion to Approve Payment to Crystal Acquisition Company Limited* filed on June 11, 2023 (the "Motion") by Mark C. Healy (the "Assignee"), solely in his capacity as the Assignee for the benefit of creditors of Crystal Cruises LLC (the "Assignor"), The Court, having reviewed the Motion and record in this case, finding that notice of the Motion was sufficient and properly served on interested parties pursuant to §§ 727.103, 727.111(4) and 727.113, Fla. Stat. (2023), noting that no response to the Motion was received by the Assignee or filed within the 21-day negative notice period set forth in the Objection, finding that the relief requested in the Motion is in the best interest of the Assignor's estate, and otherwise finding that good and sufficient cause exists for granting the relief set forth herein, does hereby

ORDER AND ADJUDGE that:

1. The Motion is GRANTED.
2. The payment of \$1,162,983.06 to Crystal Acquisition Company Limited ("CACL") as its Portion of the Settlement Payment is APPROVED.

3. The Assignee shall wire CACL's Portion of the Settlement Payment to the bank account identified in **Exhibit B** to the Motion and titled in the name of Genting Hong Kong Limited (IPL).
