**ORDER GRANTING MOTION FOR APPROVAL AND PAYMENT OF FEES AND
REIMBURSEMENT OF EXPENSES INCURRED BY ASTREA CVBA AS SPECIAL
COUNSEL TO THE ASSIGNEE FOR THE PERIOD OF JUNE 20, 2023 THROUGH
SEPTEMBER 30, 2024 [DE 777]**

THIS CAUSE came before the Court, without a hearing, upon the *Motion for Approval and Payment of Fees and Reimbursement of Expenses Incurred by Astrea CVBA as Special Counsel to the Assignee for the Period of June 20, 2023 through September 30, 2024 [DE 777]* (the “Motion”), filed on negative notice by Mark C. Healy (the “Assignee”), solely in his capacity as the Assignee for the benefit of creditors of Crystal Cruises LLC, Crystal Holdings U.S. LLC, and Crystal AirCruises LLC (collectively, the “Assignors”), pursuant to which Astrea CVBA seeks compensation in the amount of €19.564,55 and reimbursement of expenses in the amount of €4.585,16, for a total award of €24.149,71, for the period of June 20, 2023 through September 30, 2024, with proper adjustment for the pending foreign exchange rate. The Court, having considered the Motion and the record in this proceeding, noting that no objections to the Motion have been filed, finding that notice of the Motion was sufficient, and good cause appearing, it is hereby

ORDERED that:

1. The Motion is hereby **GRANTED**.

2. Astrea CVBA, as special counsel to the Assignee, is awarded fees in the amount of €19.564,55 and expenses in the amount of €4.585,16, for a total award of €24.149,71, which represents 100% of the fees and expenses requested in the Motion.
3. The Assignee is authorized to pay to Astrea CVBA the sum of €24.149,71, which is the balance owed, with proper adjustment for the pending foreign exchange rate.
4. In making the foregoing award, the Court finds that the amounts awarded represent reasonable compensation for actual and necessary services rendered and expenses incurred by Astrea CVBA for the benefit of the assignment estate.
