**ORDER GRANTING MOTION FOR APPROVAL AND PAYMENT OF FEES AND  
REIMBURSEMENT OF EXPENSES INCURRED BY BERGER SINGERMAN LLP AS  
COUNSEL TO THE ASSIGNEE FOR THE PERIOD APRIL 1, 2024 THROUGH  
SEPTEMBER 30, 2024 [DE 775]**

**THIS CAUSE** came before the Court, without a hearing, upon the *Motion for Approval and Payment of Fees and Reimbursement of Expenses Incurred by Berger Singerman LLP as Counsel to the Assignee for the Period April 1, 2024 through September 30, 2024 [DE 775]* (the “Motion”), filed on negative notice by Mark C. Healy (the “Assignee”), solely in his capacity as the Assignee for the benefit of creditors of Crystal Cruises LLC, Crystal Holdings U.S. LLC, and Crystal AirCruises LLC (collectively, the “Assignors”), pursuant to which Berger Singerman LLP seeks compensation in the amount of \$266,290.50 and reimbursement of expenses in the amount of \$3,232.41, for a total interim award of \$269,522.91 for the period of April 1, 2024 through September 30, 2024. The Court, having considered the Motion and the record in this proceeding, noting that no objection to the Motion was filed by any party, finding that notice of the Motion and the Hearing was sufficient, and good cause appearing, it is hereby

**ORDERED** that:

1. The Motion is **GRANTED**.

2. Berger Singerman, LLP, as counsel to the Assignee, is awarded fees in the amount of \$266,290.50 and expenses in the amount of \$3,232.41, for a total award of \$269,522.91, which represents 100% of the fees and expenses requested in the Motion.
3. The Assignee is authorized to pay to Berger Singerman LLP the sum of \$269,522.91.
4. In making the foregoing award, the Court finds that the amounts awarded represent reasonable compensation for actual and necessary services rendered and expenses incurred by Berger Singerman LLP for the benefit of the assignment estates.
