**MOTION FOR APPROVAL AND PAYMENT OF FEES AND
REIMBURSEMENT OF EXPENSES INCURRED BY BERGER
SINGERMAN LLP, AS COUNSEL TO THE ASSIGNEE FOR THE
PERIOD OF OCTOBER 1, 2025 THROUGH FEBRUARY 28, 2026**

**NOTICE OF OPPORTUNITY TO OBJECT
TO CREDITORS AND OTHER INTERESTED PARTIES:**

PLEASE TAKE NOTICE that, pursuant to Fla Stat. § 727.111(4), the Assignee may pay the fees and expenses of professional persons employed by the Assignee as set forth herein, and the Court may consider these actions without further notice or hearing unless a party in interest files an objection within 21 days from the date this paper is served. If you object to the relief requested in this paper, you must file your objection with the Miami-Dade County Clerk of the Court at 73 W. Flagler Street, Room 133, Miami, FL 33130, and serve a copy on the Assignee's counsel, Paul Steven Singerman, Esq. and Samuel Jason Capuano, Esq., Berger Singerman LLP, 1450 Brickell Avenue, Suite 1900, Miami, FL 33131, and any other appropriate person. If you do not file an objection within the time permitted, the Assignee and the Court will presume that you do not oppose the granting of the relief requested in the paper.

BERGER SINGERMAN LLP (“Applicant”), pursuant to Florida Statutes §§ 727.102, 727.109(1), (10) and (15), and § 727.111(4), and the Court’s *Order Granting Assignee’s Motion for Entry of an Order: (1) Approving Noticing Procedures, (2) Approving Proof of Claim Forms; and (3) Extending Deadline to Serve Notice of Assignment* (the “Notice Procedures Order”) entered on March 3, 2022, files this motion (the “Motion”) for approval and payment of fees in the amount of \$678,893.50 and reimbursement of expenses incurred in the amount of \$71,569.65 for a total award of \$750,463.15 in connection with its representation of Mark C. Healy (“Assignee”), in his capacity as the Assignee for the benefit of creditors of Crystal Cruises LLC (“Crystal Cruises”), Crystal Holdings U.S. LLC (“Crystal Holdings”), and Crystal Aircruises LLC (“Crystal Aircruises”, and, together with Crystal Cruises and Crystal Holdings, collectively, the “Assignors”) during the period of October 1, 2025 through February 28, 2026 (the “Application Period”). In support of the Motion, the Applicant states:

1. On February 10, 2022, the Assignor executed and delivered, and the Assignee accepted, irrevocable assignments for the benefit of creditors to the Assignee (collectively, the “Assignments”). On February 11, 2022 (the “Petition Date”), a *Petition Commencing Assignment for the Benefit of Creditors* was filed by the Assignee for each of the Assignors, thereby commencing the following cases pursuant to Section 727 of the Florida Statutes, in this Court: *In re Crystal Cruises LLC*, Case No. 2022-002742-CA-01, *In re Crystal Holdings U.S. LLC*, Case No. 2022-002757-CA-01, and *In re Crystal Aircruises LLC*, Case No. 2022-002758-CA-01 (collectively, the “Assignment Cases”).

2. Prior to the Petition Date, the Assignors were engaged in the travel and entertainment business, including operating ocean, river, and expedition cruises and conducting related activities around the world.

3. Pursuant to Florida Statutes § 727.108(7), the Applicant was retained as co-counsel, along with Nardella & Nardella, by the Assignee to perform all legal activities required for the benefit of the estates.

4. On March 3, 2022, the Court entered an order approving the employment of Applicant as counsel to the Assignee *nunc pro tunc* to February 16, 2022.

5. During the Application Period, Applicant devoted substantial time and expertise to advancing the Assignee's interests in the complex and heavily contested litigation related to the claims filed in an excess of \$1 billion by the liquidators of the Assignors' parent company ("Genting Hong Kong") and certain of its subsidiaries (the "Genting Claimants"). The work performed reflects a high level of coordination, legal analysis, trial preparation, expert engagement, and court-facing advocacy necessitated by the scope of the claims, the number of issues in dispute, and the accelerated deadlines set by the Court. Throughout the Application Period, the legal team undertook extensive efforts to manage multiple, overlapping litigation tracks—including summary judgment briefing, expert discovery, motion practice, pretrial preparation, and mediation—each of which was critical to moving the case toward resolution and protecting the estate.

6. A substantial portion of the work during the Application Period was dedicated to expert-related work in connection with the litigation with the Genting Claimants. Applicant coordinated the retention, preparation, and defense of the Assignee's expert, including reviewing thousands of pages of expert materials, preparing outlines, drafting duces tecum requests, analyzing financial records, and preparing for and defending the multi-day deposition of the Genting Claimants' expert, Dr. Lys, and the Assignee's expert, Alan Barbee. These tasks required strategic analysis, fact development, and close collaboration with the expert team. The Applicant

also reviewed, analyzed, and responded to multiple amended claims and expert disclosures filed by the Genting Claimants, necessitating significant research and motion practice, including preparing, refining, and filing motions to strike expert disclosures and amended claims.

7. The Applicant also undertook extensive briefing on the *Motion for Summary Judgment Against the Claims of Genting Hong Kong Limited, Crystal Acquisition Company Limited, Crystal Luxury Corporation Limited, Star Cruises (HK) Limited, and Star Cruise PTE Ltd.* (DE 891) filed by the Assignee (the “Motion for Summary Judgment”) seeking to disallow and recharacterize claims filed by the Genting Claimants, as well as the *Assignee’s Notice of Filing Summary Judgment Evidence* (DE 892). This work included analyzing voluminous documentary evidence, performing detailed legal and factual research, drafting and editing the Motion for Summary Judgment, and supporting declarations, preparing a reply brief, and coordinating exhibits and record citations to comply with the Court’s procedural requirements. Multiple attorneys were required to collaborate on research, drafting, and strategic refinement of the summary judgment arguments to ensure the presentation of a thorough, well-supported submission. The Applicant also prepared for and argued at the hearing on the Motion for Summary Judgment, as well as drafted, revised, and negotiated a proposed summary judgment order at the Court’s direction.

8. Intensive trial preparation likewise constituted a major component of the work performed during this Application Period. The Applicant prepared exhibit lists, witness lists, trial subpoenas, objections, deposition designations, counter designations, evidentiary analyses, witness materials, and pretrial case law binders. The Applicant also conducted numerous strategy conferences, analyzed evidentiary issues under the applicable rules, and prepared for the Court-mandated Final Pretrial Conference. The Applicant performed an extensive review and

objection process relating to hundreds of exhibits produced by the Genting Claimants, some of which required reconciliation against incomplete or inconsistent production sets.

9. In addition, the Applicant prepared for and participated in multiple hearings, including hearings on the motion to strike, case management conferences, and the summary judgment and pretrial hearings before Judge Walsh. These hearings required substantial preparation, including drafting argument outlines, analyzing case law, preparing evidentiary files, and coordinating with co-counsel and the Assignee.

10. Mediation and settlement efforts also became a significant area of focus toward the end of the Application Period. Counsel drafted a comprehensive mediation statement, reviewed financial documents and expert analyses in preparation for negotiation, engaged in extensive communications with opposing counsel and the mediator, and participated in a full day mediation session and follow up sessions. These efforts required detailed case evaluation, assessment of appellate risks, and preparation of settlement strategies for presentation to the mediator and opposing parties. As a result of these efforts, the Assignee reached a global settlement with the Genting Claimants. As a result of the settlement, the Applicant drafted, revised and finalized the *Assignee's Motion to Approve Settlement with Genting Hong Kong Limited, Crystal Acquisition Company Limited, Star Cruises (HK) Limited, Crystal International (Asia) Limited, and Star Cruise Pte. Ltd.* (DE 946) filed on February 27, 2026, the proposed order and related documents, coordinated settlement logistics, and communicated with creditors.

11. Other essential case administration tasks included reviewing and redacting invoices for fee applications, coordinating with chambers on hearing settings, conferring with creditors and third-party counsel, analyzing overseas liquidator issues, preparing notices of filing, researching

procedural and appellate questions, and coordinating document production and e-discovery matters.

12. Overall, the time reflected in this Application represents necessary and reasonable work performed to advance the case through critical phases of litigation, including expert discovery, dispositive motion practice, pretrial compliance, mediation, and trial preparation. The complexity of the issues, the volume of materials involved, and the aggressive schedule required sustained, diligent effort by multiple timekeepers with varied expertise. The work performed was essential to protecting the estate, narrowing disputed issues, and positioning the case for resolution through both adjudicative and negotiated avenues. Accordingly, the fees and expenses incurred during the Application Period were reasonable, necessary, and beneficial to the estate, and approval of the Application is warranted.

13. As of February 17, 2026, the cash balance in the estates is \$65,519,328.92 (the “Estate Funds”).

14. The Applicant, as counsel to the Assignee, has incurred fees in the amount of \$678,893.50 for legal services provided to the Assignee during the Application Period as identified in the chart below and expenses in the amount of \$71,569.65 (for a total of \$750,463.15) in the nature of court reporter fees, photocopy charges, e-discovery storage fees, and other expenses. Applicant’s invoice is attached hereto as **Exhibit “A”**. The summary of the fees and expenses incurred are as follows:

Given the nature of these proceedings, and the amount of work that went into representing the Assignee during the Application Period, the Applicant respectfully requests that the Court approve this Application and allow the Applicant an award of fees in the amount of \$678,893.50 and reimbursement of expenses in the amount of \$71,569.65, for a total of \$750,463.15 for the period of October 1, 2025 through February 28, 2026.

WHEREFORE, the Assignee respectfully requests that this Court enter an Order, in the form attached hereto as **Exhibit “B”**, (i) granting the Motion; (ii) approving the Applicant’s request for compensation for services rendered in the amount of \$678,893.50 and reimbursement of expenses incurred in the amount of \$71,569.65, (iii) authorizing the Assignee to pay the Applicant the sum of \$750,463.15 representing the fees and expenses awarded; and (iv) granting such other and further relief as the Court deems just and proper.

ORDERED that:

1. The Motion is **GRANTED**.
2. Berger Singerman, LLP, as counsel to the Assignee, is awarded fees in the amount of \$678,893.50 and expenses in the amount of \$71,569.65, for a total award of \$750,463.15, which represents 100% of the fees and expenses requested in the Motion.
3. The Assignee is authorized to pay Berger Singerman LLP the sum of \$750,463.15.
4. In making the foregoing award, the Court finds that the amounts awarded represent reasonable compensation for actual and necessary services rendered and expenses incurred by Berger Singerman LLP for the benefit of the assignment estates.
