**ORDER GRANTING ASSIGNEE’S SIXTH OMNIBUS OBJECTION TO DISPUTED
WAGE AND LATE CLAIMS**

THIS CAUSE came before the Court upon the *Assignee’s Sixth Omnibus Objection to Disputed Wage and Late Claims* filed on April 6, 2026 (the “Objection”) by Mark C. Healy (the “Assignee”), solely in his capacity as the Assignee for the benefit of creditors of Crystal Cruises LLC (the “Assignor”), as an Objection to the Proofs of Wage and Late Claims (the “Claims”) submitted to the Assignee by Lakhvinder Singh Vohra; Zeetours Cruises; Qualitours Agencia de Viagens e Turismo LTDA; Marcel Peliciu; Mircea Atanasiu; Stephen Bone (the “Claimants”). The Court, having reviewed the Objection and record in this case, finding that notice of the Objection was sufficient and properly served on the Claimants and to interested parties pursuant to §§ 727.103, 727.111(4) and 727.113, Fla. Stat. (2022), noting that no response to the Objection from the Claimants was received by the Assignee or filed within the 21-day negative notice period set forth in the Objection, finding that the relief requested in the Objection is in the best interest of the Assignor’s estate, and otherwise finding that good and sufficient cause exists for granting the relief set forth herein, does hereby

ORDER AND ADJUDGE that:

1. The assignee’s Objection is SUSTAINED as to the Claims of the Claimants whose claims are


attached as Exhibit “A” to the Objection and otherwise set forth in the Objection.
