
**AGREED ORDER SUSTAINING ASSIGNEE’S AMENDED OBJECTION TO CLAIM
2823 OF JACKSON MEMORIAL HOSPITAL AND SUSTAINING IN PART AND
DENYING IN PART ASSIGNEE’S AMENDED OBJECTION TO CLAIM 2697 OF
JACKSON MEMORIAL HOSPITAL**

THIS MATTER came before the Court upon the Assignee’s Amended Objection to Claim 2823 of Jackson Memorial Hospital [ECF 770] (the “Claim 2823 Objection”) filed on September 17, 2024 by Mark C. Healy (the “Assignee”), solely as the Assignee for the benefit of creditors of Crystal Holdings U.S., LLC, Crystal Cruises LLC, and Crystal Aircruises, LLC (the “Assignors”), objecting to Claim No. 2823 (“Claim 2823”) filed by Jackson Memorial Hospital (the “Claimant” or “Jackson Memorial”), and the Assignee’s Amended Objection to Claim 2697 of Jackson Memorial Hospital [ECF 771] (the “Claim 2697 Objection” and referred to together with the Claim 2823 Objection as the “Objections”) filed on September 17, 2024 by the Assignee, objecting to Claim No. 2697 (the “2697 Claim” and referred to together with the 2823 Claim as the “Claims”)) filed by Jackson Memorial Hospital. The Court, having reviewed the Objections, the Claims and the record in this case, finding that notice of the Objections was sufficient, being advised of the agreement between the Parties as to the treatment of the Claims and the form of this Order, and being otherwise fully advised in the premises, does hereby

ORDER AND ADJUDGE that:

1. The Assignee's Objection to Claim 2697 is hereby SUSTAINED in part and DENIED in part as set forth below.
2. \$35,000.00 of Claim 2697 is allowed and shall be deemed and treated as a general unsecured claim against the Assignor's Estate.
3. The balance of the Claim 2697 is denied.
4. The Assignee's Objection to Claim 2823 is hereby SUSTAINED and Claim 2823 is hereby denied in its entirety.
5. Neither Jackson Memorial Hospital, nor its agent OVAG International AG (the "Agent") who filed the Claims as Agent on behalf of Jackson Memorial Hospital, shall have any claim upon the assets of the Assignor's Estate except as is expressly set forth in this Order and the Assignee's partial allowance of Claim 2697.
6. Payment on Claim 2697 shall be made to Jackson Memorial Hospital. No payment shall be made to the Agent.
7. The Assignee is authorized to take all actions necessary and appropriate to give effect to this Order.
8. The terms, conditions, and provisions of this Order shall be immediately effective and enforceable upon entry hereof.
9. This Court retains jurisdiction to interpret, implement, and enforce the provisions of this Order.
